

ARTICLES OF INCORPORATION

We, the undersigned George W. Fuller, Mrs. W.D. Fuller, George S. Warren, A.L. Honiker, J.L. Bair, O.C. Otterson, Charles F. Sears, E.A. Sherwin, H.L. Swift, Gus Leinert, Frank Smith, Henry Ihrig and Richard Pellett, all citizens and resident free-holders of the County of Shoshone, State of Idaho, do hereby organize and form a private Corporation under the laws of the State of Idaho; and for the purpose of such organization we hereby state and declare as follows to wit:

F I R S T

The name of such Corporation is The Wallace Opera House Association.

S E C O N D

The purpose for which said corporation is formed is, to purchase suitable ground, construct thereon and maintain a building for the use of Opera and Theatrical troupes, Store rooms, Military or Society headquarters and to be used for any purpose which a Public Hall may be appropriated.

T H I R D

The principal place of business of the said corporation shall be in the Town of Wallace, Shoshone County, Idaho.

F O U R T H

The said corporation shall exist for Fifty Years from the date hereof.

FIFTH

The number of Directors for said corporation shall, until otherwise ordered, consist of the following named ^{five} persons, whose names and residence are as follows, to wit:

George W. Fuller, Wallace, Shoshone County, Idaho,

O.C. Otterson,

A.L. Honiker,

Chas. F. Sears,

E.A. Sherwin,

who shall be the directors of said corporation for the first year, and until their successors are elected and qualified.

SIXTH

The Capital Stock of said Corporation shall be Fifty Thousand (50,000) Dollars, divided into fifty thousand shares of One Dollar each.


