KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, Dale R. Young, A. D. Hurt, and Victor Maier, being natural persons of legal age and citizens of the United States of America; bona fide residents of the State of Idaho, do hereby, associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and we do hereby adopt the following Articles of Incorporation, to-wit:

ARTICLE I.

The name of said corporation shall be "MISSIONS EXPANDING, INC."

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The location and postoffice address of its registered office and principal place of business shall be Box 124, Caldwell, Canyon County, Idaho.

ARTICLE IV.

The purposes for which this corporation is formed are:

To conduct religious services, of any nature, that pertain to the Christian cause.

To conduct radio and television broadcasts.

To encourage gospel missionary work in every nation and to send missionaries to the fields whereunto God calls them.

To receive and disburse all missionary funds.

To prepare, educate and ordain ministers to the ministry as ordained of God.

To conduct Christian Secular Schools and Schools of Theology, Training Centers, Youth Camps, Conferences, Seminars, and Conventions as needs arise, in harmony and proportion with our abilities to meet the needs.

To print, distribute, and circulate literature of a religious nature.

To purchase, own, hold, lease, sell, convey, mortgage, or otherwise hypothecate real estate and personal property of all kinds and descriptions necessary or incident to or in connection with its religious work.

To erect buildings and other structures necessary and proper for the carrying out of the purposes above mentioned; to borrow money and to do any and all other things whatsoever which may be requisite and necessary

and proper in and about the carrying out of the purposes and objects for which this corporation is organized.

ARTICLE V.

The number of Directors for the incorporation of this corporation shall be three (3).
