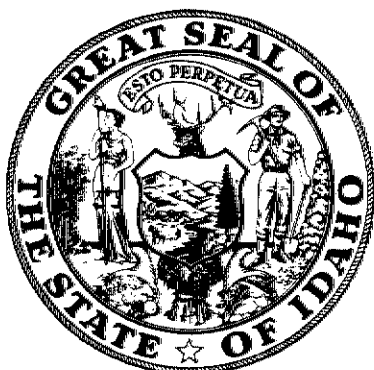

**ARTICLES OF INCORPORATION
OF
SOUTH EAST BOISE, IDAHO, CONGREGATIONS OF
JEHOVAH'S WITNESSES, INC.
A NON-PROFIT CORPORATION**

The undersigned, in order to form a nonprofit religious, benevolent, charitable, educational, Christian and philanthropic corporation pursuant to the Idaho Nonprofit Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is SOUTH EAST BOISE, IDAHO, CONGREGATIONS OF JEHOVAH'S WITNESSES, INC. ("Corporation").

ARTICLE II

The Corporation is not for pecuniary profit and it shall not have or issue capital stock, but shall be supported by gifts, bequests, contributions and benefits as may be received, together with dues, if any, of its members. Membership in the Corporation shall not entitle any person to any interest in the assets of the Corporation, but only to participate in the management of the affairs of the Corporation through meetings of the members legally called. No part of the receipts or income of the Corporation shall inure to the benefit of, or be distributable

to any individual member, members or officers of the Corporation, other than for the furtherance of the objects and purposes of the Corporation.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The objects for which the Corporation is formed are to further the preaching and teaching of the Gospel of God's Kingdom; to proclaim the overall Supremacy of Almighty God, Jehovah; to conduct schools and classes for teaching and to teach the Bible and Bible Truths; to buy, sell, or give away and otherwise distribute Bibles and other literature concerning and containing information and comment explaining Bible Truths and prophesy concerning the establishment of Jehovah's Kingdom under Jesus Christ; to hold title to and establish a Kingdom Hall as a meeting place and place of worship for the members of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES and the BOISE EAST CONGREGATION OF JEHOVAH'S WITNESSES.

ARTICLE V

In carrying out the purposes set forth in Article IV, the Corporation shall have all such powers as are inherent in or given to such corporations by the laws of the State of Idaho.

ARTICLE VI

Any person who is duly recognized as a member of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES or the BOISE EAST CONGREGATION OF JEHOVAH'S WITNESSES by the WATCHTOWER BIBLE AND TRACT SOCIETY, Brooklyn, New York, shall be a Member of the Corporation, and any person who shall subsequently become duly recognized as a member of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES or the BOISE EAST CONGREGATION OF JEHOVAH'S WITNESSES by the WATCHTOWER BIBLE AND TRACT SOCIETY, Brooklyn, New York, shall likewise become a Member of the Corporation.

ARTICLE VII

The affairs of the Corporation shall be under the management and control of a Board of Directors of not fewer than four (4) persons, all of whom must be Members of the Corporation. The number of such Directors and the length of their respective terms of office shall be fixed and determined by such constitution and by-laws as may, from time to time, be adopted by the Membership of the Corporation, except that initially, the number of Directors shall be four (4) in number, and the term of office of each Director shall be one (1) year, or until their successors have been duly elected and qualified.

ARTICLE VIII

The location and post office address of the registered office of the Corporation shall be 1876 Malad Lane, Boise, ID 83705, and the name of its initial registered agent at such address is Stuart F.C. Bennett.

ARTICLE IX
