KNOW ALL MEN BY THESE PRESENTS, that the undersigned, for the purpose of amending the Articles of Incorporation of SAFE PLACE MINISTRIES pursuant to Sections 30-3-90 and 30-3-91 of the *Idaho Code*, do hereby certify, declare, and adopt the following Articles of Amendment:

I.

The current name of the corporation is SAFE PLACE MINISTRIES, INC.

II.

Article IV of the original Articles of Incorporation filed by the Incorporator of this corporation provide that "the stockholders of the corporation shall constitute its members." Instead, from the date these Articles of Amendment are filed with the Idaho Secretary of State's Office, the corporation shall no longer have stockholders or members.

III.

Article V of the original Incorporator of this corporation provided that "the corporation shall have only one (1) class of membership which shall be voting membership. Each member shall be entitled to one vote for each share of stock owned." Instead, from and after the date that these Articles of Amendment have been filed with the Idaho Secretary of State's Office there shall be no membership voting rights for this corporation. Instead, the affairs of the corporation shall be governed solely by its Board of Directors.

IV.

Instead of the three (3) specific purposes of the corporation set forth in Article III of the Articles of Incorporation originally filed for this corporation, from and after the date that these Articles of Amendment have been filed with the Idaho Secretary of State's Office, the purpose of the corporation shall be amended to include the following:

VI.


There are presently no shares of stock issued and outstanding and no shares of stock entitled to vote upon these Articles of Amendment.

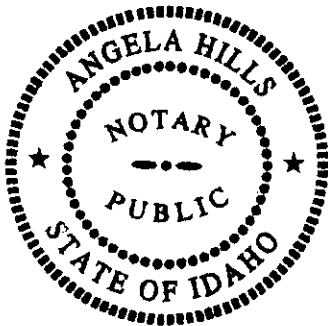
