We, the undersigned, in compliance with the requirements of Idaho Uniform Limited Partnership Act Section 53-233, hereby file a Restated Certificate of Limited Partnership, which original Certificate of Limited Partnership was filed in Cassia County, State of Idaho on the 29th day of December, 1976, and hereby swear to and certify as follows:

FIRST: The Name of the Partnership. The name of the Partnership is HUNSAKER FAMILY PARTNERSHIP, a Limited Partnership.

SECOND: The Character of the Business. The character of the business is to acquire, own, operate, improve, lease and sell real properties acquired by the partnership, including farms, ranches and other investments, and personal properties acquired from time to time by the partnership and to engage in any and all other lawful business activities.

THIRD: Location of Principal Place of Business. The location of the principal place of business of the Hunsaker Family Partnership is:

FIFTH: Term of the Partnership. The term for which the partnership is to exist is for one year after organization and thereafter from year to year until terminated as provided by the Articles of Limited Partnership.

SIXTH: Value of Assets Contributed. The amount of cash and a description of and the agreed value of the other property contributed by each Limited Partner is set forth in Exhibit A.

SEVENTH: Additional Contributions. No additional contributions have been agreed to be made by any Limited Partner.

EIGHTH: Return of Contribution. No time has been agreed upon when the contribution of each Limited Partner is to be returned.

NINTH: Allocation of Profits and Losses. The share of the profits, or the other compensation by way of income, which each Limited Partner shall receive by reason of his or her contribution or subsequent gifts of limited partnership interests is set forth in Exhibit B.

TENTH: Right of Substitution. Without the prior consent of the General Partners, no Limited Partner may substitute an assignee as contributor in his or her place.

ELEVENTH: Admission of Additional Limited Partners. The General Partners may admit one or more additional Limited Partners, which additional Limited Partners, unless donees of a part of the partnership interest of a General Partner, shall be required, as a condition to being admitted as a Limited Partner, to contribute to the capital of the partnership such amount of cash or other marketable properties as may be necessary to avoid diluting the interests of the existing Limited Partners.

TWELFTH: Priority of Limited Partners. No right has been given to one or more of the Limited Partners to priority over other Limited Partners as to contributions, or as to compensation by way of income.

THIRTEENTH: Continuation of Business. Upon the death, adjudicated incapacity or retirement of a General Partner, the remaining General Partner shall have the right to continue the partnership business or to wind up and liquidate the partnership.

FOURTEENTH: Return for Contribution. No Limited Partner has been given the right to demand and receive property other than cash in return for his or her contribution.
