To the Secretary of State of the State of Idaho pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends its Articles of Incorporation as follows:

1. The name of the original corporation set forth in the original Articles of Incorporation dated the 13<sup>th</sup> day of May, 1908, named the original corporation the First Methodist Episcopal Church of Kimberly, Idaho, and the Certificate of Change of Name and Amendment of Articles of Incorporation dated 30<sup>th</sup> day of September, 1960, and the Certificate of Amendment of Articles of Incorporation issued the 14<sup>th</sup> day of October, 1960 changed the name of the corporation so that said name is now **FIRST METHODIST CHURCH OF KIMBERLY.**
2. The above described Articles of Incorporation and Amendment of the Articles of Incorporation are hereby further amended to change the name of the corporation to **CROSSROADS UNITED METHODIST CHURCH, Inc.**
3. The Articles of Incorporation dated May 13, 1908, states that "the number of trustees who shall have the management of its affairs as aforesaid shall be six (6)..."
4. The above-referred paragraph is hereby amended to read as follows, "the number of trustees who shall have the management of its affairs as aforesaid shall be nine (9) and each trustee's term of service shall be three (3) years."
5. The Board of Trustees is also known as the Board of Directors. The Officers of the Corporation are as follows:
