



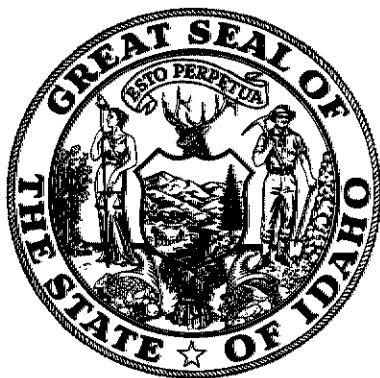
**CERTIFICATE OF INCORPORATION
