#### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED, BEING THREE OR MORE NATURAL PERSONS OF FULL AGE AND CITIZENS OF THE UNITED STATES AND RESIDENTS OF THE STATE OF IDAHO, AS MEMBERS OF SPIRIT LAKE MASONIC LODGE # 57 A.F. & A.M. OF IDAHO, HAVE ASSOCIATED AND DO HEREBY ASSOCIATE OURSELVES TOGETHER FOR THE PURPOSE OF FORMING A FRATERNAL CORPORATE ORGANIZATION UNDER THE PROVISIONS OF SECTION 30, CHAPTER 3 OF THE IDAHO CODE.

#### ARTICLE FIRST

THE NAME OF THE CORPORATION SHALL BE SPIRIT LAKE LODGE # 57, ANCIENT FREE AND ACCEPTED MASONS OF IDAHO, INCORPORATED., AND ITS PRINCIPLE OFFICE FOR THE TRANSACTION OF BUSINESS SHALL BE IN SPIRIT LAKE, IDAHO.

#### ARTICLE SECOND

THE CORPORATION SHALL EXIST PERPETUALLY OR UNTILL DISSOLVED ACCORDING TO LAW.

#### ARTICLE THIRD

THIS CORPORATION SHALL NOT ENGAGE IN ANY FORM OF TRADE OR COMMERCE, NOR, DIRECTLY OR INDIRECTLY, FIX THE PRICE OR REGULATE THE PRODUCTION OF ANY ARTICLE OF COMMERCE OR THE PRODUCE OF THE SOIL, OR THE CONSUMPTION OF THE SAME BY THE PEOPLE NOR CARRY ON ANY ACTIVITY WHICH WILL RESULT IN A RENUMERATIVE PROFIT TO THE CORPORATION OR ITS MEMBERS. SUBJECT TO THE FOREGOING LIMITATIONS, THE BUSINESS PURSUIT, PURPOSE AND OBJECTIVES OF THIS CORPORATION ARE FRAIERNAL, PATRIOTIC, HISTORICAL AND EDUCATIONAL: TO PRESERVE AND STRENGTHEN BROTHERHOOD AMONG ITS MEMBERS, TO ASSIST WORTHY BROTHERS, TO PERPETUATE THE MEMORY AND HISTORY OF OUR DEAD AND TO ASSIST THEIR WIDOWS AND ORPHANS; TO MAINTAIN TRUE ALLEGIANCE TO THE GOVERNMENT OF THE UNITED STATES OF AMERICA, AND FIDELITY TO ITS CONSTITUTION AND LAWS; TO FOSTER TRUE PATRIOTISM; TO MAINTAIN AND EXTEND THE INSTITUTIONS OF AMERICAN FREEDOM; AND TO PRESERVE AND DEFEND THE UNITED STATES FROM ALL HER ENEMIES WHOMSOEVER.

#### ARTICLE FOURTH

THE ACTIVE AND VOTING MEMBERSHIP OF THIS CORPORATION SHALL AT ALL TIMES CONSIST OF AND BE CONFINED TO THE ACTIVE MEMBERSHIP IN GOOD STANDING IN SPIRIT LAKE LODGE # 57, A.F. & A.M., OF IDAHO WITH ELIGIBILITY TO AQUIRING OF SUSPENSION FROM AND DISCONTINUANCE OF MEMBERSHIP BEING IN ACCORDANCE WITH THE CODE AND DIGEST, LAWS RULES AND REGULATIONS OF THE GRAND LODGE, A.F. & A.M. OF IDAHO, TOGETHER WITH THE BYLAWS OF SPIRIT LAKE LODGE # 57, A.F. & A.M.

## ARTICLE FIFTH

THIS INCORPORATED SUBORDINATE UNIT OF THE GRAND LODGE A.F. & A.M. OF IDAKO SHALL AT ALL TIMES, REMAIN UNDER THE JURISDICTION OF AND BE GOVERNED ACCORDING TO THE CODE & DIGEST OF THE GRAND LODGE A.F. & A.M. OF IDAHO. IN THE EVENT THAT ANY PROVISION OF THIS CERTIFICATE OF INCORPORATION CONFLICTS WITH THE CODE & DIGEST OF THE GRAND LODGE A.F. & A.M. OF IDAHO, SUCH CONFLICTING PROVISIONS SHALL BE DEEMED NULL AND VOID AND THE AFOREMENTIONED CODE & DIGEST SHALL AT ALL TIMES GOVERN.

#### ARTICLE SIXTH

IN THE EVENT OF A DISOLUTION OF THIS CORPORATION, ALL OF THE ASSETS SHALL BE THE PROPERTY OF THE SPIRIT LAKE LODGE # 57, A.F. & A.M. OF IDAHO; AND IN THE EVENT OF THE SIMULTANEOUS DISOLUTION OF THIS CORPORATION AND OF THE FORFEITURE OF THE CHARTER ISSUED BY THE GRAND LODGE A.F. & A.M. OF IDAHO TO SAID SUBORDINATE UNIT, THEN AND IN THAT EVENT TITLE TO ALL OF THE ASSETS OF THIS CORPORATION SHALL PASS TO THE GRAND LODGE A.F. & A.M. OF IDAHO TO BE DISPOSED OF IN ACCORDANCE WITH THE CODE AND DIGEST OF THE SAID GRAND LODGE, A.F. & A.M. OF IDAHO. AT NO TIME SHALL THE ASSETS OF THE CORPORATION BE DISTRIBUTED AMONG THE INDIVIDUAL MEMBERS THEREOF.

#### ARTICLE SEVENTH

THESE ARTICLES MAY BE AMMENDED IN THE MANNER PROVIDED BY THE IDAHO CODE AT THE TIME OF THE AMMENDMENT AND IN ACCORDANCE WITH THE CODE AND DIGEST OF THE GRAND LODGE A.F. & A.M. OF IDAHO; AND THE BYLAWS OF SPIRIT LAKE LODGE # 57, A.F. & A.M.

#### ARTICLE EIGHTH

ALL MEETINGS SHALL BE CONDUCTED IN THE ENGLISH LANGUAGE ONLY.

## ARTICLE NINTH

THE GENERAL OFFICERS OF THE CORPORATION SHALL BE PROVIDED IN THE BYLAWS; NO DIRECTORS.

#### ARTICLE TENTH

ALL OTHER MATTERS PERTAINING TO THE ORGANIZATION AND OPERATION OF THE CORPORATION NOT HEREIN PROVIDED FOR SHALL BE DETERMINED AND FIXED BY THE BYLAWS.
