

ARTICLES OF INCORPORATION

We, the undersigned citizens of the United States and residents of Nez Perce County, Idaho, do hereby associate ourselves together for the purpose of forming a nonprofit corporation in accordance with the provisions of Chapter 3, Title 30, of the Idaho Code, entitled "Nonprofit Corporations", and the laws of the State of Idaho relating to the forming of corporations where pecuniary profit is not the object, do hereby certify and declare as follows:

ARTICLE I

The name of the corporation is the Waha Lake Association, Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

This corporation is not organized for pecuniary profit and it shall have no powers to declare dividends and it shall not have or issue any capital stock. Membership in the corporation shall not entitle a person to any interest whatsoever in the assets of the corporation, but only to participate in the management of the affairs of the corporation in meetings of the members legally called and held within the period covered by the membership and the by-laws.

#### ARTICLE IV

This corporation is organized exclusively for the promotion of furthering the quality of the environment and the objectives and purposes to be transacted and carried on are as follows:

To secure grants from public sources for lake and watershed restoration and beautification and to administer those grants in the accomplishment of specific projects and to assist and coordinate with government agencies in securing grants and to educate and inform the public about the lake and watershed management.

#### ARTICLE V

The affairs of the Association shall be managed by a Board of Directors, hereinafter designated as the Board, under such rules as the Board may determine, subject to the speceific conditions of the Association By-laws.

#### ARTICLE VI

The location of the principle place of business of this corporation shall be Lewiston, Nez Perce County, Idaho, but any question as to the area involved for membership purposes shall be subject to determination by the Board of Directors.

## ARTICLE VII

The name and address of the initial registered agent of the corporation is as follows:

## ARTICLE VIII

The board of directors of the corporation shall be seven (7) in number. The names and addresses of the first directors are as follows:

The board of directors shall be selected from those who are members of this corporation and the number, qualification, terms of office, manner of election, time and place of meeting and powers and duties shall be prescribed in the by-laws of this corporation.

## ARTICLE IX

The number of directors of the corporation is herein specified, but such number may from time to time be increased or decreased in such manner as may be prescribed in the by-laws. In a case of an increase in the number of directors, the additional directors may be elected by the directors then in office and the directors so elected shall hold office until the next annual meeting of the members and until a successor is properly elected and qualified.

## ARTICLE X

The corporation may be dissolved by a two-thirds (2/3) vote of all members at a meeting or by unanimous written consent of all members. If dissolution is favorably acted upon, all just debts shall be paid out of the funds of the corporation, and all remaining funds, if any, shall be donated to the Idaho Department of Fish and Game to be used to benefit Waha Lake.

## ARTICLE XI

These articles may be amended in any manner permitted or authorized by law, by the favorable vote of two-thirds (2/3) majority of the members present or represented by proxy at a meeting of the members duly called upon notice for the specific purpose thereof, and containing a statement of the proposed amendment.

## ARTICLE X

The corporation may be dissolved by a two-thirds (2/3) vote of all members at a meeting or by unanimous written consent of all members. If dissolution is favorably acted upon, all just debts shall be paid out of the funds of the corporation, and all remaining funds, if any, shall be donated to the Idaho Department of Fish and Game to be used to benefit Waha Lake.

## ARTICLE XI

These articles may be amended in any manner permitted or authorized by law, by the favorable vote of two-thirds (2/3) majority of the members present or represented by proxy at a meeting of the members duly called upon notice for the specific purpose thereof, and containing a statement of the proposed amendment.
