1 ARTICLES OF INCORPORATION

3 BAR 7 X RANCH, INC.

5 KNOW ALL MEN BY THESE PRESENTS: That we, JUNIA JONES, EDDIE JONES,  
6 FREELAND THORSON and NANCY KISER, all residents of Weiser, Idaho, and each of  
7 whom is a citizen of the United States and the State of Idaho, over the age of  
8 twenty-one years, desiring to form a corporation under and by virtue of the laws of  
9 the State of Idaho, do hereby associate ourselves together for said purpose and  
10 execute, acknowledge, adopt and file the following Articles of Incorporation:  
11

12 ARTICLE I.  
13

14 The name of this corporation shall be BAR 7 X RANCH, INC.  
15

16 ARTICLE II.  
17

18 The names and addresses of the persons so associating themselves together for the  
19 purposes aforesaid are JUNIA JONES of Weiser, Idaho, EDDIE JONES, of Weiser,  
20 Idaho, FREELAND THORSON of Weiser, Idaho, and NANCY KISER of Weiser,  
21 Idaho, all of whom are over the age of twenty-one years;  
22

23 ARTICLE III.  
24

25 That the general nature of the business to be transacted by this corporation and the  
26 objects and purposes for which this corporation is formed are as follows:  
27

28 To acquire, own, hold and operate land and livestock and to carry on and operate  
29 a general farming, ranching and livestock business; to acquire by purchase lands,  
30 livestock, farm machinery and other equipment necessary or beneficial in the oper-  
31 ation of the land and livestock business; to borrow money and to issue therefor its  
32 notes, bonds or other evidence of indebtedness and to secure the payment of the  
same by pledge agreement, trustee mortgage or chattel mortgage upon any and all

1 of the real and personal property of said corporation and generally to acquire such  
2 real and personal property as may be necessary for the purposes for which this  
3 corporation is formed; and to perform whatever additional acts may be necessary or  
4 desirable for the accomplishment of the purposes for which this corporation is  
5 organized;  
6

7 ARTICLE IV.

8 The principal place of business and registered office of this corporation shall be  
9 Weiser, Idaho, and there may be such other subordinate and branch offices here-  
10 after established either within or without the State of Idaho as the Board of  
11 Directors of said corporation may determine;  
12

13 ARTICLE V.

14 The authorized capital stock of this corporation shall be Five Hundred Thousand  
15 (\$500,000.00) Dollars, divided into five thousand (5,000) shares of the par value  
16 of One Hundred (\$100.00) Dollars, per share, which shares of stock shall be non-  
17 assessable and all certificates of stock issued to any purchaser of stock of this  
18 corporation shall have printed thereon the following words: "This stock is fully  
19 paid up and is non-assessable."

21 ARTICLE VI.

22 That all of said capital stock has been subscribed by the following names persons  
23 in the amounts set opposite their respective names:

1 ARTICLE VII.

2 The government and management of the business of this corporation shall be  
3 vested in a Board of four (4) Directors and the said Junia Jones, Eddie Jones,  
4 Freeland Thorson and Nancy Kiser shall be and constitute the first Board of  
5 Directors of this corporation and shall hold their offices as such until their  
6 successors are elected and qualified.  
7

8 ARTICLE VIII.

9 The Directors, as well as the stockholders, shall have power to make such  
10 prudential By-Laws as they may deem proper for the management of the corpor-  
11 ation, not inconsistent with the general By-Laws of the corporation, and power  
12 is hereby conferred upon the Board of Directors by a three-fourths vote of said  
13 Directors to repeal and/or amend the general By-Laws of the corporation and to  
14 adopt new general By-Laws.

17 ARTICLE IX.

18 The time of commencement of this corporation shall be the date on which a copy  
19 of these Articles of Incorporation is filed in the Office of the Secretary of the  
20 State of Idaho, and in the Office of the County Recorder of Washington County,  
21 Idaho, and this corporation shall have continuous and perpetual existence.  
22


