The undersigned individual, desiring to form a corporation in accordance with Title 30, Chapter 1, Idaho Code, does hereby submit the following Articles of Incorporation.

**ARTICLE ONE**  
**NAME**

The name of the corporation shall be R. WILSON CONSTRUCTION, INC.

**ARTICLE TWO**  
**PURPOSES**

The purposes for which the corporation is organized are as follows:

- (1) To engage in the business of operating a construction company; and
