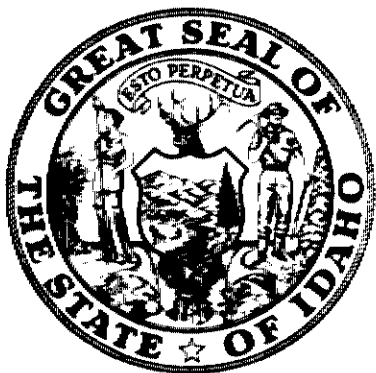

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
SADDLE ROAD CORPORATION

Pursuant to the provisions of Section 30-1-61, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I.

The current name of the corporation is Saddle Road Corporation.

II.

The following Amendments to the Articles of Incorporation was adopted by the Shareholders of the Corporation on December 5, 1988, in the manner prescribed by Section 30-1-59, Idaho Code:

Paragraph I of the Articles of Incorporation is amended to read as follows:

"I.

The name of the corporation is Trump Corporation."

III.

The number of shares of the corporation outstanding at the time of such adoption was one hundred (100) shares of common stock, and the number of shares entitled to vote thereon was one hundred (100) shares.

IV.

The number of shares voted for such Amendment was one hundred (100) shares; and the number of shares voted against such Amendment was zero (0).
