KNOW ALL MEN BY THESE PRESENT, that we the undersigned hereby associate ourselves together for the intention of forming a private non-profit corporation, under the provisions of Title 30, Chapter 3, Idaho Code, and do hereby execute, subscribe, and acknowledge in triplicate, the following ARTICLES OF INCORPORATION:

ARTICLE I

The name by which this corporation shall be known is Potlatch Senior Citizens, Inc.

ARTICLE II

business, to enable said corporation to carry out these objects and purposes it shall have the power to purchase, lease or otherwise acquire real and personal property, said property to belong to the Potlatch Senior Citizens, Inc.; to enter into contracts or obligations of any type or kind necessary or proper for the accomplishment of the purposes for which the said corporation is organized, or which shall at any time appear conducive or expedient for the protection or benefit of said corporation, or in the furtherance of its activities, or any of them.

ARTICLE III

The duration of this corporation shall be perpetual.

ARTICLE IV

The principal place of business of this corporation shall be at Rebekah Hall, in the City of Potlatch, County of Latah, State of Idaho.

ARTICLE V

The corporation shall have no capital stock; and the rights and interests of all older persons, 60 years of age and over, and spouses, shall be equal, with none having the right to acquire a greater interest than any of the others.
