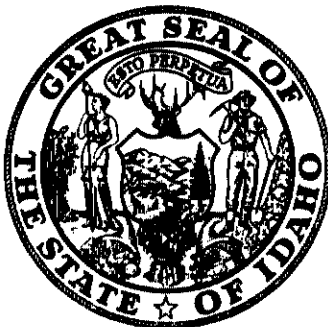
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION OF

SUITS PLUS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is Suits Plus, Inc.

SECOND: The period of the Corporation's duration is perpetual.

THIRD: The objects and purposes for which this Corporation is organized shall be the transaction of any or all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The capital stock of this Corporation shall consist of One Hundred (100) shares of nonassessable, common stock, with a par value of zero (0).
