**ARTICLE I.**

That the name of the corporation shall be WILD WEST PROMOTIONS, INC.

**ARTICLE II.**

The purposes for which the corporation is organized shall be, and include, the transaction of any and all lawful business for which a corporation may be incorporated under "The Idaho Business Corporation Act."

**ARTICLE III.**

This corporation shall have perpetual existence.

**ARTICLE IV.**

The location and post office address of the registered office in this State and principal place of business shall be 3322 E. 1<sup>st</sup> Avenue, Post Falls, Idaho 83854, and the initial registered agent at such address is Donald E. Smith.

#### ARTICLE V.

There shall be only one class of capital stock of this corporation, which shall be designated as common stock, and such common stock shall be and consist of 100,000 shares with a par value of \$1.00 totaling in the aggregate sum of \$100,000.00.

#### ARTICLE VI.

The number of directors constituting the initial Board of Directors of the corporation shall be two (2). The number of directors and officers may from time to time be fixed by the bylaws of the corporation at any number.

Subject to the power of the shareholders to amend, alter or repeal, the Board of Directors of this corporation shall have the power to amend such bylaws defining the powers and duties of the officers in the corporation and providing for such other matters regarding its affairs that they deem necessary and convenient, providing the same are not out of harmony with the laws of the State of Idaho, or these Articles of Incorporation.

ARTICLE VIII.

An amendment altering the Articles of Incorporation of this corporation in any respect may be adopted by vote of the holders of the majority of the outstanding shares unless specifically prohibited by law, then by such vote as law requires.

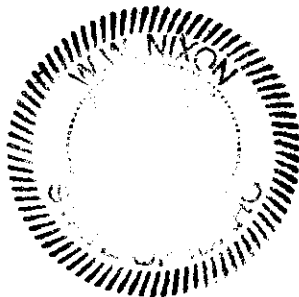
