

Articles of Incorporation of the Copper King Mining Company

Know all men by these presents, that we the undersigned, a majority of whom are citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify,

First.

That the name of the corporation shall be the Copper King Mining Company

Second.

That the purposes for which this corporation is formed are to conduct a general mining, milling and smelting business, to locate and hold, purchase, buy and sell mining claims and mining property and do any and all things consistent with and necessary to successfully carry on and conduct a general mining, milling and smelting business.

Third.

That the place where the principal business of this corporation is to be transacted is Montpelier, Bear Lake County, Idaho.

Fourth.

That the term for which this corporation is to exist shall be Fifty years from and after the date hereof.
