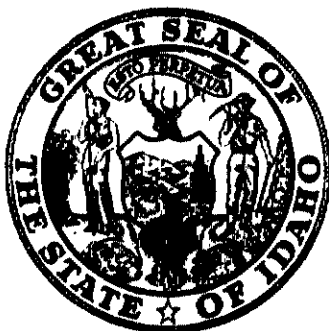
### CERTIFICATE OF INCORPORATION OF

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

Madison County Snowmobile Club, Inc.

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the purpose of promoting the sport of snowmobiling, particularly as a family recreational sport and to educate the public generally as to the sport of snowmobiling and any or all other lawful purposes for which corporations may be incorporated under the Idaho Business Corporation Act.

4. Corporate Membership.

Membership in the Corporation will be had by application to the Corporation. Any person of legal age may apply for membership. Membership shall be extended to any person so applying unless that person has been convicted of a felony or crime of moral turpitude. Membership may be evidenced by a certificate, card, or other instrument, as may be determined by the corporation. The Corporation is authorized to levy assessments upon all its members

for purposes of obtaining the necessary capital to run the day to day business affairs of the Corporation. Any assessments must first be authorized by the Board of Directors. A failure of the member to pay his assessment, within twenty days written notice of the same by the Corporation, may result in the cancellation of the membership certificate, card, or other evidence of membership. No assessment levied by the Corporation shall be a lien on any property of any member and the Corporation shall not have the right of legal action to collect unpaid assessments but shall only have the right of membership forfeiture for unpaid assessments.

5. Registered Agent and Office.

The name of the initial registered agent and the name of the initial registered office of the corporation is: Doyle Barney, 546 East Barney Dairy Road, Rexburg, ID 83440.

6. Directors.
