AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **Perpetual Existence** from the date hereof, with its registered office in this State located at **Silver City, Idaho** in the County of **Owyhee** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
OF
THE OWYHEE FOUNDATION OF IDAHO, INCORPORATED

* * * * *

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a corporation not for profit under Section 30-1101 of the Idaho Code, as amended, and under the laws of the State of Idaho, in general, and we do hereby certify, declare and adopt the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be THE OWYHEE FOUNDATION OF IDAHO, INCORPORATED.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

The location of the registered office of this corporation shall be in the City of Silver City, Owyhee County, State of Idaho, and the address of the registered office of this corporation shall be c/o Owyhee Avalanche, Silver City, Owyhee County, Idaho. The activities of the corporation shall not be

confined to the City of Silver City, State of Idaho, but will include any surrounding territory supportive of the purposes of the corporation.

ARTICLE IV

The purpose of this corporation shall be to promote the historical restoration and/or preservation and educational perpetuation of Silver City and its environs.

Further, the following powers are enumerated as consistent with the foregoing objectives:

(a) To receive gifts and grants of money and property of every kind and to administer the same for charitable, educational, social welfare and civic uses and improvements, and to do anything necessary or proper for the accomplishment of these purposes.

(b) To enter into, make and perform and carry out contracts of every sort and kind with any person, firm, association or corporation, municipality, body politic, country, territory, district, state and government.

(c) To institute, enter into, carry on, assist, promote or participate in financial, commercial, mercantile, industrial and other businesses, works, enterprises, undertakings and operations.

(d) To carry on any other business which may seem to the corporation capable of being conveniently carried on in connection with its business or calculated directly or

indirectly to enhance the value of or render profitable any of the corporation's property or rights.

(e) The said corporation may perform any part of its business outside the State of Idaho, in the other states, in the District of Columbia, territories or possessions, or dependencies of the United States.

(f) To do each and all things set forth herein to the same extent and as fully as natural persons might do or could do in the State of Idaho, and in any other state, country or place.

(g) The foregoing clauses shall be construed as objects, purposes and powers; and it is hereby expressly provided that any enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation.

(h) To do all and every thing necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes, or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

ARTICLE V

In furtherance, and not in limitation of the powers confirmed by statute, the Board of Directors is expressly authorized:

To make and alter By-Laws of this corporation, and to authorize and cause to be executed mortgages and liens upon the real and personal property of this corporation.

This corporation may in its By-Laws confer powers upon its directors in addition to the foregoing and in addition to the powers and authorities expressly conferred upon them by statute.

The title to all real estate acquired by the corporation shall at the time of its acquirement or immediately thereafter be vested in a trust company, or in two or three reputable citizens of the community in which the activities of the corporation are carried on, with a provision in the deed that, in the event of the dissolution of the corporation, or the revocation or lapse of its charter, said trustee or trustees, after satisfying any claims against the corporation to which such real estate may be subject, shall convey said property, or if sold, pay the net proceeds of such sale to the County of Owyhee, State of Idaho, or to a successor corporation dedicated to the same principles enumerated.

ARTICLE VI

The corporation formed hereby shall have no capital stock and shall be composed of members rather than shareholders.

The conditions and regulations of membership and the rights or other privileges of the classes of members shall be determined and fixed by the By-Laws of the corporation.

No interest of any member in this corporation shall be assignable or transferable, and no membership in this association shall be considered as having any monetary value. Any member may be expelled from the corporation upon the conditions and for the reasons as may be specified in the By-Laws.

The corporation shall have no power to issue certificates of stock or to declare or pay dividends, its object and purpose being solely of a benevolent character and not for pecuniary profit to its members.

ARTICLE VII

This corporation shall be the successor in interest to the heretofore existing Owyhee Foundation, and is hereby formed pursuant to resolution, unanimously adopted by the members of said association at an election held on the 2nd day of June, 1973, at the hour of 10:00 o'clock A.M., at the address of the Owyhee Avalanche, Silver City, Owyhee County, Idaho.

Notice of time and place of said election was published for more than two weeks prior thereto in two weekly editions of The Owyhee Chronicle, a newspaper published and circulated in Owyhee County, Idaho, and caused such notice to be posted continuously for more than two weeks prior to such election in the building and room where said election was held

for the same length of time. Said notice expressly stated that the purpose of such meeting would be for the election of the directors to constitute the Board of Directors of this corporation.

At such meeting, by motion duly made and seconded, a resolution was adopted whereby a unanimous ballot was cast for the election of the following-named persons to constitute the Board of Directors of this corporation:

ARTICLE VIII

The name and post office address of each of the incorporators is set out at the end hereof by their signatures hereto, together with such post office address.

ARTICLE IX

The private property of the members of this corporation shall not be subject to the payment of corporate debts to any extent whatsoever, regardless of how such debts are incurred.

ARTICLE X

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all acts conferred upon members herein are granted, subject to this reservation.

WE, THE UNDERSIGNED, Being each one of the original members hereinbefore mentioned for the purposes of forming a

corporation not for profit to do business both within and without the State of Idaho, and in pursuance of the laws of the State of Idaho, do make and file these Articles of Incorporation, hereby declaring and certifying that the facts herein stated are true, and we respectively agree to become members of such corporation, and accordingly have hereunto set our hands and seals this 11th day of June, 1973.


