AMENDMENT OF RESTATED ARTICLES OF INCORPORATION

A special meeting of the shareholders of Jacobsen Manufacturing Company, a corporation organized under, and existing by virtue of, the Statutes of the State of Wisconsin, duly was called and convened pursuant to the Restated Articles of Incorporation and the By-Laws of said corporation on the 18th day of September, A. D. 1967, at the hour of 10:00 A. M., Central Daylight Time. There were present at said meeting, either in person or by proxy, the holders of 54,950 preferred shares of said corporation and the holders of 441,004 common shares of said corporation. At said meeting the following Resolution duly was adopted:

RESOLUTION

RESOLVED that Article III of the Restated Articles of Incorporation of Jacobsen Manufacturing Company be, and the same hereby is, amended so as to read as follows:

ARTICLE III: The aggregate number of shares which this corporation shall have authority to issue shall be 1,570,000 consisting of 70,000 6% Cumulative Preferred Shares, \$1.00 par value per share, and 1,500,000 Common Shares, \$1.00 par value per share.

Bunck, Secretary, of Jacobsen Manufacturing Company, hereby do certify that the foregoing Resolution amending Article III of the Restated Articles of Incorporation of said corporation duly was adopted at a special meeting of the shareholders of said corporation duly called and convened on the 18th day of September, A. D. 1967, at the hour of 10:00 in the forenoon of said day, Central Daylight Time, in accordance with the Restated Articles of Incorporation and the By-Laws of said corporation.

We further certify that the whole number of shares of said corporation issued and outstanding at the time of the holding of said special meeting was 70,000 6% cumulative preferred shares, \$1.00 par value per share, and 573,226 common shares, \$1.00 par value per share; that none of said preferred shares were entitled to vote at said special meeting; that all of said common shares were entitled to vote at said special meeting; that 439,227 of said common shares voted at said special meeting in favor of said Resolution and 1,777 of said common shares voted against said Resolution.

We further certify that the foregoing copy of Resolution amending Article III of the Restated Articles of Incorporation of said corporation is a true, full and correct copy of the original thereof and that the same has not been amended or rescinded in whole or in part at the date hereof.
