

ARTICLES OF INCORPORATION OF THE SOUTH-
BOISE MUTUAL IRRIGATION COMPANY, LIMITED.

Know All Men By These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho,-

and we hereby certify:

First. That the name of said corporation is "The South-Boise Mutual Irrigation Company, Limited.

Second. That the purposes for which it is formed are the supplying and conducting water to the stockholders of said corporation, for agricultural, domestic and village purposes, and to that end to purchase or otherwise acquire, own, control, maintain, improve and enlarge that certain ditch taking water out of Boise River at a point on the Charles Holcomb ranch in Ada County, Idaho, together with all water-rights, laterals and other appurtenances thereunto belonging; and to locate, construct, lease, purchase or otherwise acquire such other ditch or ditches, canals, sluices, sluice ways, laterals, dams, reservoirs and reservoir sites, land, water and water rights as may be necessary or convenient to the carrying out of its objects and purposes; and to borrow money, levy maintenance and improvement assessments on the stock of this corporation, and to do all other acts and things necessary, essential or proper to the carrying out of the said objects and purposes.

Third. That the place where its principal business is to be transacted shall be the Village of South-Boise, Ada County, Idaho.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth. That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:

Sixth. That the amount of the capital stock of this corporation shall be Twenty-thousand (\$20,000.00) Dollars, divided into One-thousand (1000) shares, of the par value of Twenty (\$20.00) Dollars each; that to each share of stock of this corporation shall be inseparably attached the right to the perpetual user of one inch of water measured under a four inch pressure, and that each share of stock shall be subject to such assessments for maintenance charges and expenses as may be determined upon from time to time by the Board of Directors.

Seventh. That the amount of said capital stock which has been actually subscribed is Nine-thousand-Three-hundred-Ninety and 40/100 (\$9,390.40) Dollars, and the following are the names of the persons by whom the same has been subscribed, to wit:
