IDENTIFICATION

Gary L. Thomas, whose address is 2069 Division St., Boise, ID 83706, is hereby appointed the initial registered agent of this Corporation.

ARTICLE FIVE

BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors. The initial Board of Directors shall consist of three (3) directors, provided however, that the number of directors may be changed in accordance with the Bylaws of the Corporation. VOTING RIGHTS

ARTICLE EIGHT

CODE OF BYLAWS; INDEMNIFICATION; AMENDMENTS OF ARTICLES

The Board of Directors of the Corporation shall have the power to make, alter, amend, or repeal the Bylaws of the Corporation, subject to the restriction that a majority vote of the Directors is necessary to take these actions.

The Corporation shall indemnify a director or officer of the Corporation who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the director or officer was a party because the director or officer is or was a director or officer of the Corporation against reasonable expenses incurred by the director or officer in connection with the proceeding.

ARTICLE NINE

DISSOLUTION

Upon dissolution of the Corporation, other than incident to a merger or consolidation, the assets of the Corporation shall be distributed to the shareholders in accordance with the number of shares owned.

ARTICLE TEN

DURATION

The corporation shall exist perpetually.

ARTICLE ELEVEN

AMENDMENTS

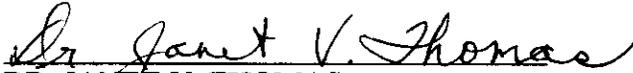
Amendment of these Articles shall require the assent of seventy-five percent (75%) of the entire number of shares.

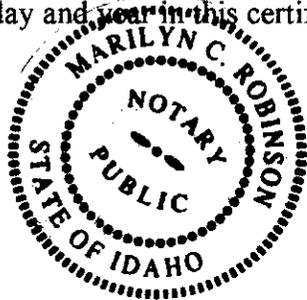
