## PLAN OF MERGER

- SECOND: The Disappearing Entity is White Horse Media, Inc., a California non-profit corporation formed under the laws of California, currently in good standing, whose Articles of Incorporation were filed with the California Secretary of State on May 19, 1989 with file number C1641405 and who is duly registered as a foreign corporation in good standing with the State of Idaho by certificate of authority filed April 9, 2014 as filing number C201778.
- THIRD: The effective date of this merger shall be the date the Statement of Merger in this matter is filed with the Idaho Secretary of State.
- **FOURTH:** This merger does not require an amendment to the Articles of Incorporation or any other public organic document of the Surviving Entity.
- FIFTH: The Surviving Entity, White Horse Ministries, Inc, an Idaho Corporation shall adopt the tax exempt status, by-laws and other governing documents of the Disappearing entity subject to appropriate revision to comply with Idaho laws. Further, the Directors and Officers of the Disappearing Entity shall hereby be appointed as Directors and Officers of the Surviving Entity with authority to take actions necessary to revise and adopt the governing documents into the Surviving Entity and with authority to file as appropriate notice of such Merger with the State of Idaho, Secretary of State and State of California, Secretary of State.
