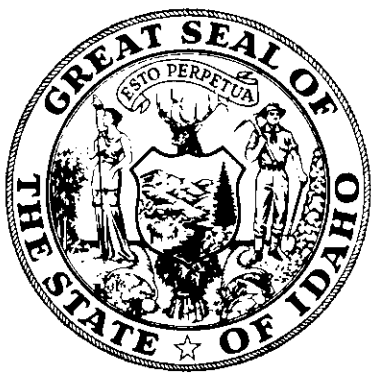

ARTICLES OF INCORPORATION
OF
TRADER LAKES COMPANY

I, the undersigned, incorporator for the purpose of forming a corporation under and pursuant to Title 30, Chapter 1 of the Idaho Code, do hereby certify the following:

I.

The name of this corporation shall be:

TRADER LAKES COMPANY

II.

The duration of this corporation shall be perpetual.

III.

The purpose of this Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Idaho.

IV.

The location of the registered office of this corporation in the State of Idaho shall be 14395 East Hayden Lake Road, Hayden Lake, Idaho 83835, and the resident agent at that address is LINDA GLOE.

V.

The aggregate number of shares which this corporation shall have the authority to issue is 600 shares, with a par value of \$100.00 per share, having an aggregate par value of \$60,000.00 which shall be known as common stock. This stock, to the extent possible, shall be issued pursuant to the provisions of Sec. 1244 of the Internal Revenue Code.

All or any portion of these Articles of Incorporation may be amended by the affirmative vote of the holders of a majority of the stock entitled to vote.

IX.

The management of this corporation shall be vested in a Board of Directors consisting of not less than one or more than five Directors to be elected at the annual meeting of this corporation.

X.

The officers of this corporation shall consist of a President,


Vice-President, Secretary and Treasurer, and any two of the offices, except those of President and Secretary, may be held by the same person, unless provided otherwise by law.
