**ARTICLES OF INCORPORATION
OF
GARY LANE LATERAL NO. 18, INC.
(A NONPROFIT CORPORATION)**

The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Idaho Nonprofit Corporation Act, Idaho Code Section 30-301 et seq., adopts the following Articles of Incorporation:

1. **Article 1.** The name of this corporation is GARY LANE LATERAL NO. 18, INC., and it is a nonprofit corporation organized pursuant to Idaho Code Section 30-301 et seq.

2. **Article 2.** The period of duration of this corporation is perpetual.

3. **Article 3.** The purpose for which this corporation is organized is for the orderly and organized delivery of irrigation water to the property owners adjacent to and owning shares in the water delivered through Boise Valley Irrigation Ditch Lateral #18, which runs parallel to Gary Lane and West near Gillis Road in Ada County, Idaho, and for such other lawful purposes associated with the said delivery of irrigation water, such as, but not limited to, maintenance and upkeep of ditches, pipes, culverts, headgates and the monitoring of water flows and drainage patterns, and related matters.


4. **Article 4.** The corporation has members and the management of its affairs is to be vested in its members pursuant to Idaho Code Section 30-314(c).


