ARTICLES OF INCORPORATION

STONYRIDGE LABRADOR RETRIEVERS AND HUNT CLUB, INC.

I, the undersigned, J. Lawrence Stoune, being of the age of eighteen (18) years or more, and acting as incorporator under the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I

NAME

The name of this corporation shall be Stonyridge Labrador Retrievers and Hunt Club, Inc.

ARTICLE II

This corporation is authorized to issue only one (1) class of shares of stock. The total number of shares which this corporation shall be, and is hereby authorized to, issue is One thousand (1,000) shares all of which shall be without par value.

ARTICLE III

Each share of stock issued pursuant to Article II shall have and equal voting right, and no share shall have any preference whatsoever.

ARTICLE IV

ARTICLE V

ARTICLE VI

There shall be no personal liability of the director to the corporation or his stockholders for monetary damages for breach of fiduciary duty as a director, except for breach of the director's duty of loyalty, acts or omissions not in good faith, intentional misconduct, knowing violation of law, or any transaction from which the director derived an improper personal benefit, or as set forth in Idaho Code § 30-1-833.

ARTICLE VII


The corporation shall indemnify and hold directors harmless, from any liability, as defined in Idaho Code § 30-1-850(5), to any person for any action taken, or any failure to take any action as a director, except liability for: receipt of a financial benefit to which that director was not entitled, an intentional infliction of harm upon the corporation or its shareholders, a violation of I.C. 30-1-833, or for an intentional violation of criminal law.

ARTICLE VIII

The purposes for which this corporation is organized are:

1. To perpetuate and expand the hunting skills of Labrador Retrievers;
2. To provide a private limited hunting environment for a variety of water fowl sportsmen;
3. To train all canine hunting breeds;
4. To propagate all varieties of water fowl and game birds for scientific observation, training and marketing;
5. To keep and maintain a professional kennel and related services;
6. To selectively breed and market Labrador Retrievers;
7. To study, develop and preserve wetlands and waterfowl habitat and their related ecosystems for scientific, educational , commercial and philanthropic purposes;
8. To hold field trials and hunt tests for the general public;
9. To engage in all other lawful activity for which a corporation may be formed and operated.
