# ARTICLES OF INCORPORATION OF HENDERSON LUMBER COMPANY

The undersigned, in order to form a corporation pursual to The TY Office Idaho Business Corporation Act, certify as follows:

#### ARTICLE I

The name of the corporation is <u>Henderson Lumber Company</u> (hereafter "Corporation")

#### ARTICLE II

The purposes for which this corporation is organized are as follows:

- 1. To engage in <u>lumber sales and distribution</u>; and
- 2. To engage in any other lawful activity or business for which corporations may be in corporated under the Idaho Business Corporation Act.

#### ARTICLE III

The Corporation shall have perpetual existence.
