

ARTICLES OF INCORPORATION  
OF THE  
BONNER COUNTY SHERIFF'S POSSE, INC.

We, the undersigned, all residents of the State of Idaho and citizens of the United States of America, of full age of majority, have, for the purpose of forming a non-profit corporation, adopted the following Articles of Incorporation:

ARTICLE I

The name of this corporation is the Bonner County Sheriff's Posse, Inc.

ARTICLE II

This corporation is a non-profit corporation.

ARTICLE III

This corporation shall have perpetual duration.

ARTICLE IV

The purpose and objects for which this corporation is formed are as follows:

1. To form a non-profit corporation for the protection and service of, and to, individual members of the corporation and to further their common interests.

2. To further the welfare, reputation and progress of Bonner County, to be public spirited, to promote good fellowship and the love for good horses; to uphold and defend the Constitution of the United States of America and of the Bonner County Sheriff's Posse in the observance of civic

function and to bring in closer fellowship the individual members of the Bonner County Sheriff's Posse.

#### ARTICLE V

This corporation shall have all the powers granted corporations under the laws of the State of Idaho. The corporation shall have the incidental powers to do everything necessary, suitable or proper for the accomplishment, attainment or furtherance of, to do every other act or thing incidental to, appurtenant to, growing out of or connected with the purposes, objects or powers set forth in these Articles of Incorporation whether alone or in association with others, to possess all the rights, powers and privileges now or hereafter conferred by the laws of the State of Idaho, and in general to carry out all of the activities and to do any of the things herein set forth to the same extent and as fully as a mature person or partnership might or could do, provided that nothing herein set forth shall be construed as authorizing the corporation to possess any purpose, object or power, or to do any thing or act forbidden by the laws to a non-profit corporation.

#### ARTICLE VI

The number of directors of this corporation shall be not less than three (3) nor more than five (5). The names and addresses of the persons who are to serve as directors until successors are elected and qualified pursuant to the By-Laws of this corporation are:




