KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED, IN ORDER TO FORM A CORPORATION FOR THE PURPOSES HEREINAFTER STATED, PURSUANT TO THE IDAHO BUSINESS CORPORATION ACT, AS NOW IN EFFECT OR AS MAY HERE AFTER BE AMENDED, DO HEREBY CERTIFY AS FOLLOWS;

ARTICLE 1

THE NAME OF THIS CORPORATION SHALL BE SOLAR SOLUTIONS, INC.

THE PERIOD OF DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

ARTICLE 3
