ARTICLES OF INCORPORATION

OF

STROSCHEIN RANCHES, INC.  
a corporation

TO ALL TO WHOM THESE PRESENTS MAY COME:

We, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full legal age, do under and pursuant to the General Corporation Laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of STROSCHEIN RANCHES, INC., a corporation.

ARTICLE I

The name of this corporation shall be:

STROSCHEIN RANCHES, INC.

ARTICLE II

The purposes for which this corporation is formed are:

- a. To engage in, to conduct, to maintain and to carry on all and every kind of agricultural pursuit.
- b. To grow produce, to buy, handle, store and sell crops of all types and kind produced or raised upon premises owned or leased by such corporation.
- c. To engage in and to carry on all methods for assisting in the better production of crop, or crops, including testing and experiments, either on the crops on lands owned by said corporation or other lands, all to the end that larger and better crops may be produced and that the purposes of the corporation may be carried out.
- d. To conduct and carry on the business of selling and distributing and dealing in all kinds of feed and agricultural products and in kindred and incidental lines.
- e. To maintain and operate elevators and storage warehouses for grains produced and raised on premises owned or leased by such corporation.
- f. To develop wells and other water supplies.

- g. To acquire, own and hold such real and personal property as may be necessary or convenient for the transaction of the business of such corporation.
- h. To borrow money, to sell lands, to purchase lands, to receive lands for its capital stock and to do each and everything essential, including the borrowing of money and the mortgaging of the premises owned and the crops produced by the said corporation.
- i. To do each and everything that is essential or connected with the purposes of this corporation and, with that end in view, to acquire, buy, purchase, lease, hire or otherwise acquire lands or any interest therein, to approve the same and generally to improve the property of the company and to enter into contracts of every nature and kind that is deemed advisable and best for the company.
- j. To raise and deal in livestock of every nature and kind.
- k. To do each and everything necessary, essential or advisable for the accomplishment of any one or more of the said purposes of said corporation.

#### ARTICLE III

The principal place of business of said Corporation shall be in Sterling, Bingham County, Idaho.

#### ARTICLE IV

The term of this corporation shall be perpetual.

#### ARTICLE V

The corporate power and business shall be exercised and controlled by a Board of three directors.

#### ARTICLE VI

The amount of the capital stock shall be \$100,000.00 divided into 1,000 shares of common stock of the par value of \$100.00 per share.
