KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all of whom are citizens and residents of the United States, do hereby make and execute the following articles of Incorporation for the purposes of organizing a business corporation under the laws of the State of Idaho, as defined in Title 30, Idaho Code, and we hereby certify:

NAME

I.

The name of the corporation shall be J. D. JACOBS CO.

P U R P O S E

II.

The purposes for which this corporation is formed are as follows:

- (a) Buying, selling, exchanging, trading and in every and all manner dealing in trucks, tractors, threshing machines, combine harvesters and farm implements, equipment and machinery of all kinds, industrial, construction and mining equipment and machinery of all kinds, and parts, accessories and supplies of all kinds for said equipment and machinery.
- (b) Repairing any and all kinds of machinery and equipment that this corporation is authorized to deal in.
- (c) Producing, storing, processing and marketing of all types of agricultural products.
- (d) Buying, selling, exchanging and in every other manner dealing with agricultural products.
- (e) Acquiring, owning, using, operating, renting, leasing, mortgaging and conveying and otherwise disposing of and in every manner dealing with real and/or personal property or any interest therein.

- (3) To conduct the business of the corporation in the State of Idaho and other states of the United States and to have one or more offices and places of business outside of the State, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situated out of the State of Idaho.
 - (3) To engage in the business of farming and livestock raising.
- (h) To exercise in addition to the foregoing powers, privileges and rights conferred upon corporations by the laws of the State of Idaho, and all powers, privileges and rights necessary, incidental or conducive to carrying out the purposes for which this corporation is formed, and the enumeration of the foregoing powers shall not be held to limit or restrict in any manner the general powers which may be possessed by this corporation, all of which are hereby expressly granted.
