Articles of Incorporation of the West Branch- Harrison Canal C  
Company, Ltd.

## ARTICLE 1.

This certifies that the undersigned have on this 26th day of April, 1901, formed a corporation for the purposes hereinafter specified, and which shall be known as the WEST BRANCH-HARRISON CANAL COMPANY, with such powers and privileges as are allowed by law.

## ARTICLE 2.

The purpose for which this corporation is formed is to take the water for agricultural, domestic and other useful purposes, from what is known as the Harrison Canal in Bingham County, Idaho.

The headgate of the main canal being located at the terminus of the Harrison Canal in the North West quarter of Section Three(3)Township Three(3( North of Range 39 E. B. M. from which water is taken by canal 12 feet wide on bottom and 3 feet deep, in a western direction to the south-east corner of the South East quarter of Section thirty-three(33) in Township four(4) North of Range 38 E.B.M

## ARTICLE 3.

The place where the principal business is to be transacted is Ako, Bingham County, Idaho.

## ARTICLE 4.

The corporation is to exist for a period of fifty years.
