RE: Use of the Word "Bank" in Company Name in Idaho

Dear Mr. Podvin:

The Idaho Department of Finance (Department) received your letter date May 2, 2019, informing us that your client, Gateway Mortgage Group, LLC, has been granted a bank charter establishing Gateway First Bank, by the Oklahoma Banking Department, effective May 3, 2019. The one office of Gateway Mortgage Group, LLC, in Idaho will become a loan production office (LPO) of the bank on that date, and will operate under the name "Gateway Mortgage Group, a division of Gateway First Bank."

Idaho Code § 26-302 governs LPOs operating in the State of Idaho and sets forth the information required in the notice to establish a LPO. The information provided in your letters dated May 2 and January 23, 2019, satisfy the requirements of Idaho Code § 26-302.

Idaho Code § 26-1202 provides that "no person may advertise or transact business in this state under a name or title that contains the word "bank," "banker," "bancorp," "savings bank," "trust company," or a word or words of similar import, unless the person has been granted a charter to engage in banking or trust business in this state by the director, or unless the director has granted the person a waiver from this prohibition as set forth in this section. However, Idaho Code § 26-1202(2) states that the "prohibition shall not apply to a ... state-chartered bank or trust company located in another state that has obtained all approvals that may be required under the law as a prerequisite to doing business in this state."

Since the statute does not apply to a state-chartered bank, there is no need for the Director of the Department to grant a waiver to a state-chartered financial institution to use the word "bank" in its name in Idaho. Under these circumstances, the Department offers "no objection" to Gateway
