whose names are hereunto subscribed, desiring to form a corporation providing for the creation of a non-profit corporation, do hereby associate ourselves togethereand make and execute in triplicate the following articles of incorporation, to wit:

## ARTICLE I

The name assumed by this corporation and by which it shall be known is TEN MILE COMMUNITY CHURCH and its duration shall be perpetual.

#### ARTICLE II

This corporation shall not engage in any form of trade or commerce, or carry on any activity which will result in a remunerative profit to the corporation or to its members. Subject to the foregoing limitations, the object, business, or pursuit of this corporation shall be as follows:

to establish and maintain a place of worship; to evangelize the lost and to edify the saved.

### ARTECLE III

The estimated value of the property and money possessed by this corporation at the time of executing these articles of incorps oration is property values. 260.00 and money \$1,150.00 and its revenues shall be derived from the contributions, donations, tithes, and bequests of its members and friends.

#### ARTICLE IV

- (1) The names and official titles, if any, and the postoffice addresses of the persons executing these articles are:

- (2) The foregoing persons are to be the governing body which is to exercise the powers of the corporation.
