ARTICLES OF INCORPORATION

of

TEN MILE COMMUNITY CHURCH

We the board members: Robert Waitley, Herbert Nits and

Fred Vogeney Jr.

whose names are hereunto subscribed, desiring to form a corporation providing for the creation of a non-profit corporation, do hereby associate ourselves together and make and execute in triplicate the following articles of incorporation, to wit:

ARTICLE I

The name assumed by this corporation and by which it shall be known is TEN MILE COMMUNITY CHURCH and its duration shall be perpetual.

ARTICLE II

This corporation shall not engage in any form of trade or commerce, or carry on any activity which will result in a remunerative profit to the corporation or to its members. Subject to the foregoing limitations, the object, business, or pursuit of this corporation shall be as follows:

to establish and maintain a place of worship; to evangelize the lost and to edify the saved.

ARTICLE III

The estimated value of the property and money possessed by this corporation at the time of executing these articles of incorporation is property value \$25,000.00 and money \$1,150.00 and its revenues shall be derived from the contributions, donations, tithes, and bequests of its members and friends.

ARTICLE IV

(1) The names and official titles, if any, and the postoffice addresses of the persons executing these articles are:

The board members: Robert Waitley, Herbert Nitz, Fred Vogeney
Route 2, Meridian, Idaho.

(2) The foregoing persons are to be the governing body which is to exercise the powers of the corporation. (If this is not the case, state in the following space the true nature of the board of deacons or directors, officers or other governing body which will exercise the powers of the corporation.)

The board members shall hold in trust the property and possessions
of said corporation in agreement with the foregoing standards and
in agreement with the members and principles of Ten Mile Community
Church.

(3) The successors to the corporators, or the board of deacons or directors, officers or other such governing body will be elected annually by the members of the Ten Mile Community Church

ARTICLE V

The location and principal office of this corporation shall be at Meridian, Idaho in Ada County, Idaho.
