ARTICLES OF INCORPORATION

OF

HOME SERVICE CORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is "Home Service Corporation."

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized are for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 20000 shares of the par value of \$100.00 per share, or a total of \$2,000,000.00, and all shares of the capital stock of this corporation shall be known as common stock, with each share of stock to be entitled to one vote. All shares are non-assessable.

ARTICLE V.

The address of the initial registered office of the corporation is 500 Twelfth Avenue South, Nampa, Idaho 83651, and the name of its initial registered agent at such address is Larry B. Gates.

ARTICLE VI.

The number of directors constituting the initial board of directors of the corporation is six, and the names and addresses


