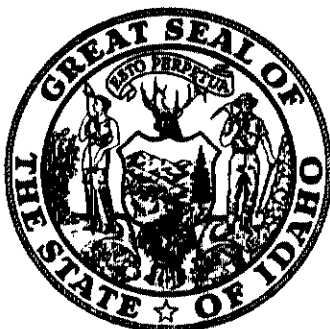
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
DURA SHINE AUTO DETAILS, INCORPORATED

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act (Idaho Code §30-1-1 et seq) adopt the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is DURA SHINE AUTO DETAILS, INCORPORATED.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purposes for which this corporation is organized is to wash, clean, wax, paint and detail motor vehicles; sell pin stripes, seat covers, and other auto accessories; and to transact any other lawful business for which corporations may be incorporated under this act.

IV. STOCK

The aggregate number of shares which this corporation shall have the authority to issue is ONE HUNDRED THOUSAND (100,000) shares common voting stock at \$10.00 per share par value.
