ARTICLES OF INCORPORATION

of

JOSLYN AND JOHNSTON, INC.

KNOW ALL MEN BY THESE PRESENTS, That We, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation, for the purpose hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

Ι

The name of the corporation is "JOSLYN AND JOHNSTON, INC."

The purposes for which said corporation is formed are: The carry on the business of stationers, printers, lithographers, stereotypers, electrotypers, photographic printers, photo-lithographers, engravers, die-sinkers, book-printers, account-book manufacturers, dealers in parchment, dealers in stamps, advertising agents, a general advertising business, both as principals and agents, including the preparation and arrangement of advertisements and the manufacture and construction of advertising devices and novelties, and the preparation and printing and distribution of advertising in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets or other similar literature and advertising medium, including the preparation of posters, billboards, and all other advertising devices, to act as designers, draftsmen, ink manufacturers, booksellers, publishers, paper manufacturers, photo engravers, and dealers in materials used in the manufacture of paper and dealers in or manufacturers of any other articles or things of

a character similar or analogous to the foregoing, or any of them, or connected therewith; to own and operate equipment and properties, both real and personal, used in any of the foregoing activities or businesses or enterprises.

To take, own, hold, deal in, mortgage or otherwise give liens against, and to lease, sell, exchange, transfer, or in any manner whatever to dispose of real or personal property within or without the State of Idaho, wherever situated; to manufacture, purchase, or otherwise acquire in any lawful manner, to hold, own, mortgage, pledge, or otherwise to give liens against, to lease, sell, assign, exchange, transfer or in any manner dispose of, to deal and trade in and with, and to invest in goods, wares and merchandise and property of any and every class and description, both within Idaho and out of Idaho and in any part of the world.

To acquire the good will, rights and property, and the whole or any part of the assets, tangible or intangible, and to undertake or in any way assume the liabilities of any person, firm, association or corporation, to pay for the said good will, rights, property, and assets in cash, in the stock of this corporation, in bonds or otherwise, or by undertaking the whole or any part of the liabilities of the transferor; to hold or in any manner to dispose of the whole or any part of the property so purchased; to conduct in any lawful manner the whole or any part of any business so acquired and to exercise all the powers necessary or convenient in and about the conduct and management of such business.

To apply for, purchase, register, or in any manner to acquire, and to hold, own, use, operate and introduce and to sell, lease, assign, pledge or in any manner dispose of, and in any manner deal with patents, patent rights, licenses, copyrights, trade-marks, and trade names; to acquire, own, use, or in any manner dispose of any and all inventions, improvements, processes, labels, designs, brands, or other rights, and to work, operate, or develop the same; and to carry on any business, manufacturing or otherwise, which may directly or indirectly effectuate these objects or any of them.

To purchase, hold, sell, assign, transfer, mortgage, pledge, or otherwise dispose of, and to guarantee the shares of the capital stock of, or any bonds, securities, or evidences of indebtedness created by any other corporation or corporations under the laws of this state or of any other state, country, nation or government, and while owner thereof, to exercise all the rights, powers and privileges of ownership to the same extent as natural persons might or could do.

For any of the purposes of the corporation, without limit as to amount, to borrow or raise moneys, to draw, make, accept, endorse, discount, execute, pledge, issue, sell or otherwise dispose of promissory notes, drafts, bills of exchange, watrants, bonds, debentures and other instruments, whether negotiable or non-negotiable, transferable or non-transferable, and evidences of indebtedness, whether secured by mortgage or otherwise, as well as to secure the same and all obligations arising therefrom, by mortgage or otherwise, either alone or jointly, with

any other person or corporation, of the whole or any part of the property of the corporation presently owned or to be acquired.

To purchase, insofar as the same may be done without impairing the capital of the corporation, and except as otherwise permitted by law, and to hold, pledge, and reissue shares of its own capital stock; but such stock so acquired and held shall not be entitled to vote or to receive dividends.

To have one or more offices, to conduct its business, carry on its operations, and to promote its objects within and without the State of Idaho, in other states, the District of Columbia, the territories, colonies and dependencies of the United States, and in foreign countries, without restriction as to place or amount, but subject to the laws of such state, district, territory, colony, dependency or country.

To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world, as principals, agents, contractors, trustees, or otherwise, and either alone or in company with others.

In general, to carry on any other business in connection therewith, whether manufacturing or otherwise, and to do all things not forbidden by the laws of the State of Idaho, and with all the powers conferred upon corporations by the laws of the State of Idaho.

It is the intention that each of the objects, purposes, and powers specified in each of the paragraphs of the second articles of these Articles of Incorporation shall, except where otherwise specified, be nowise limited or restricted by refer-

ence to or inference from the terms of any other paragraph or of any other article in these Articles of Incorporation, but that the objects, purposes, and powers specified in this article, and in each of the articles or paragraphs herein contained, shall be regarded as independent objects, purposes and powers, and the enumeration of such specific purposes and powers shall not be contrued to restrict in any manner the general terms and powers of this corporation, nor shall the expression of one thing be deemed to exclude another, although it is of like nature. The enumeration of objects or purposes herein shall not be deemed to exclude or in any way limit by inference any powers, objects or purposes which this corporation is empowered to exercise, whether expressly by force of the laws of the State of Idaho, now or hereafter in effect, or impliedly by any reasonable construction of said law.

The total authorized stock of this corporation shall be divided into Two Hundred fifty A(250) at (2,500) shares, all of which shall be common stock without a nominal or par value.
