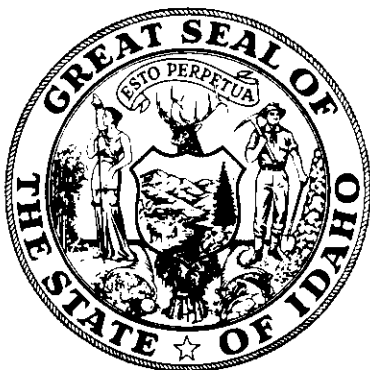

ARTICLE I: The name of the corporation: American West International, Inc.
