
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SAWTOOTH AVIATION CLINIC, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may conduct under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is 421 Pocahontus Drive, Hailey, Idaho 83333, and the name of its initial registered agent at such address is Gerry E. Burrell.




