Article 2:

This corporation is organized as a nonprofit corporation, exclusively for charitable, religious or educational purposes as defined in Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code ("IRC"), including, for such purposes: To (1) provide a place of healing for Veterans and their families suffering the effects of War. (2) To establish and maintain a safe haven for horses rescued from severe abuse and neglect to aid in the program. (3) To use equine assisted learning in a safe environment to aid in the recovery of our Veterans suffering from PTSD, TBI, Severe Stress, Depression, and Addiction.

Article 8:

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of IRC 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the district court of the county in which the principal office of the corporation is then located; exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operation exclusively for such purposes.
