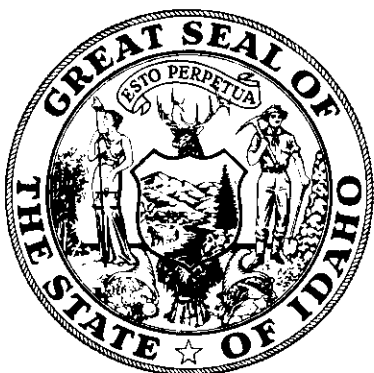

ARTICLES OF INCORPORATION

ARTICLE I

NAME

- A. The name of this non-profit corporation shall be "TREASURE VALLEY STEPSIDES AND CLASSIC TRUCKS INC."

ARTICLE II

INCORPORATION

- A. This organization shall become incorporated as a non-profit corporation and abide by the corporation laws of the State of Idaho.

ARTICLE III
