AMENDMENT TO ARTICLES OF INCORPORATION
OF

IDAHO SAVINGS AND LOAN ASSOCIATION, INC.

We, the undersigned officers, pursuant to a resolution of the shareholders at a meeting called by the Board of Directors ^{and} pursuant to Section 30-146(6), Idaho Code, and by more than a two-thirds vote of said shareholders on August 30, 1956, amended the original Articles of Incorporation of this corporation as follows, to-wit:

I

Amend the first paragraph of Article III which reads as follows:


" The authorized capital stock of the corporation is One Hundred Thousand (\$100,000.00) Dollars, which shall be divided into ten thousand shares of permanent guaranty stock of par value of \$1.00 per share, and nine hundred shares of investment stock at \$100.00 per share."


by striking said paragraph and inserting in place thereof the following paragraph:

" The authorized capital stock of the corporation is Five Million (\$5,000,000) Dollars which shall be divided into 25,000 shares of permanent guaranty stock of par value of \$1.00 per share and 49,750 shares of investment stock at \$100.00 per share."
