## ARENDMENT TO ARPICLES OF INCORPORATION

OF

IDAHO SAVINAS AND LOAD ASSOCIATION . INC.

We, the undersigned officers, pursuant to a resolution of the shareholders at a meeting called by the Board of pursuant to Section 30-146(6), Idaho Code,
Directors and by more than a two-thirds vote of said shapeholders on August 30,1956, amended the original Articles of Incorporation of this corporation as follows, to-wit:

Ι

Amend the first paragraphof Article III which reads as follows:

> The authorized capital stock of the corporation is One Hundred Thousand (\$190,000.00) Dollars, which shall be divided into ten thousand shares of permanent guaranty stock of par value of \$1.00 per share, and nine hundred shares of investment stock at \$100.00 per share.'

by striking said paragraph and inserting in place thereof the following paragraph:

> " The authorized capital stock of the corporation is Five Million (\$5,000,000) Dollars which shall be divided into 25,000 shares of permanent guaranty stock of par value of \$1.00 per share and 49,750 shares of investment stock at \$100.00 per share."
