

ARTICLES OF INCORPORATION

OF

NAMPA LIONS CLUB, INC.

The undersigned, acting as incorporators of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such non-profit corporation.

FIRST: The name of the corporation is NAMPA LIONS CLUB, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the non-profit corporation is organized is for civic purposes, including the transaction of any or all lawful business for which corporations may be incorporated in the State of Idaho.

FOURTH: The corporation will have members. Those members shall consist of the present members of the Nampa Lions Club, Inc. In addition, any new members can be added when they are proposed for membership by a current member of the Nampa Lions Club, Inc., and approved by the Board of Directors of the Nampa Lions Club, Inc., pursuant to the constitution of Lions Club International. Each member shall be entitled to one vote for any

matter that is brought before the general club.

FIFTH: The address of the initial registered office of the corporation is 923 12th Avenue South, Nampa, Idaho, 83651, and the name of its initial registered agent at such address is Richard Claiborne.

SIXTH: The number of directors constituting the initial board of directors of the corporation is twelve and the names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify are:
