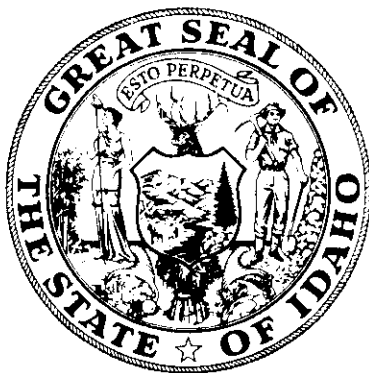

## ARTICLES OF INCORPORATION

OF

### POST FALLS DEVELOPMENT COMPANY

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

#### I

The name of the corporation is Post Falls Development Company.

#### II

The period of its duration is perpetual.

#### III

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

#### IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares of no par value common stock. The owners thereof shall have and acquire such voting rights in said corporation as provided by the laws of the State of Idaho.

#### V
