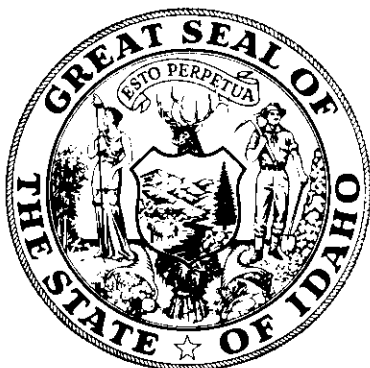

ARTICLES OF INCORPORATION

OF

SIM-TEK CORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:

SIM-TEK CORPORATION

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The authorized capital of the corporation is One Million Dollars (\$1,000,000.00). The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000), each having a par value of One Thousand and NO/100 (\$1,000.00) Dollars per share.
