**ARTICLE ONE**

**NAME**

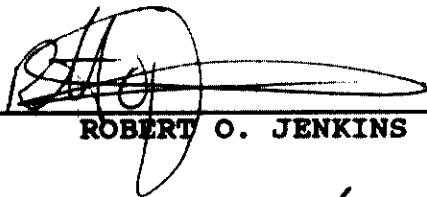

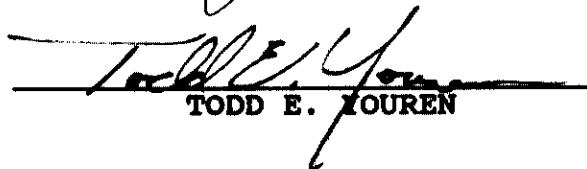

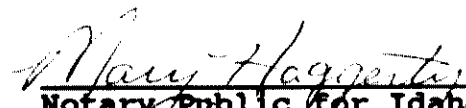
