## CERTIFICATE OF AMENDMENT TO

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned. the president and secretary respectively of the Georgetown Irrigation Company, a corporation, organized and existing under and by virtue of the laws of the state of idaho, do hereby certify as follows:

That at a special meeting of the stockholders of said Corporation duly held at the principal place of business of said Company, to-wit at the town of Georgetown, in Bear Lake County, idaho, on the 2nd day of M ay, 1947, at the hour of 8 o'clock P. M. for the purpose of considering and acting upon the proposition of Amending the Articles of incorporation, Stockholders holding more than two-thirds of the voting power of said corporation, that is to say holding I225 shares of the capital stock of said Company out of 1800 shares entitled to vote, did thereat vote to adopt and did thereby adopt the following amendement to the articles of incorporation of said company, that is to say that all of the said stockholders there present at said meeting did unanimously vote to amend Article 2 of the Articles of Incorporation of said company by providing that the Capital stock of said, Company should be increased from 1800 shares of the par value of \$1.00 each to ISIS Shares of Capital Stock of the par value of \$1.00 each, and such amendment was thereby adopted.

That the shareholders of said Company had at least Thirty days notice of the above mentioned meeting.

That the said Amendment so adopted at said meeting does not change the rights of the holders of shares of stock in said Company, in any particular. That the stock of said corporation is not divided into classes and that all of the stock of said corporation has a par value of \$1.00 each. That the amount of authorized stock of said company henceforth shall be 1818 shares.

CERTIFICATE OF EXTENSION OF CORPORATE EXISTENCE OF THE THEOREMONNE IRRIGATION COM-PANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, the Chairman and Secretary respectively of the Stockholders meeting hereinafter mentioned, do hereby certify as follows:

That the Georgetown Irrigation Company was a corporation duly organized and existing under and by virtue of the laws of the State of idaho, and that said Company was formed for a period of fifty Years and that the Charter of said Company expired through lapse of time on the 26th day of March, 1944.

That at a meeting of the stockholders of said Georgetown irrigation Company, a corporation, duly held at the call of the directors of said Company at Georgetown, in Bear Lake County, Idaho, on the 2nd day of May, 1947, it was unanimously voted by all stockholders there present, said stockholders there present representing more than two-thirds of the Capital Stock of said Company, to-wit representing 1225 shares of the capital stock of said Company out of a total of 1800 shares, to extend the corporate existence of said Company perpetually, and such extention of the corporate existence of said Company perpetually thereby became effective.
