The undersigned acting as the incorporators of a corporation under the Idaho Business Corporation Act §30-1-101 et seq., adopts the following Articles of Incorporation for Ryan Miller Builders, Inc.

**FIRST:** The name of the corporation shall be Ryan Miller Builders, Inc.

**SECOND:** The duration of this corporation is perpetual.

**THIRD:** The location of and post office address of the registered office of this corporation is P.O. Box 1412, McCall Idaho, 83638 and the name of the registered agent at that address is Ryan Miller. at 1250 Elo Rd, McCall, Id 83638.

**FOURTH:** This corporation is authorized to issue one thousand (1,000) shares of common stock of one (1) class only and all such shares shall be without par value.

**EIGHTH:** The number of directors of this corporation shall be as specified in the by-laws and such number may be increased or decreased in such manner as may be provided by the by-laws, but the number of directors shall not be less than one (1).

**NINTH:** The shareholders of this corporation shall not be liable to the creditors of this corporation for any corporation indebtedness or obligation; and the shares issued shall not be subject to assessment for the purpose of paying expenses of this corporation incurred in conducting its business.

**TENTH:** The directors of this corporation shall not be liable to this corporation or to its shareholders for money damages, losses or claims resulting from actions taken, or for the failure to take any action, as a director, except for that specific liability arising from a financial benefit received by a director to which he is now entitled, an intentional infliction of harm to this corporation or its shareholders, or an intentional violation of criminal law. Additionally, the corporation is permitted to indemnify its directors as to individual liability except as to those matters proscribed by Idaho law.

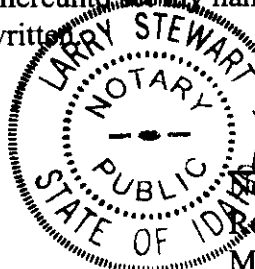
