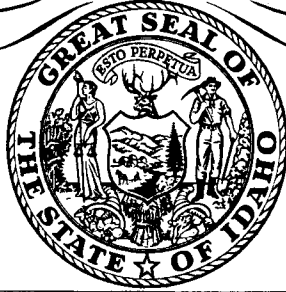

WE undersigned, being five or more natural persons of legal age, all of whom are citizens of the United States, do hereby sign the following Articles of Incorporation, representing and certifying to the Secretary of State of the State of Idaho, and all persons with it may concern, that a membership list or lists of one or more persons for which certificate of incorporation is hereby applied for, have heretofore been signed in accordance with law and that at least ten persons have signed such membership list.

ARTICLE I

The name of this corporation shall be SPRING WATER ASSOCIATION, INC.

ARTICLE II

The purpose or purposes for which it is formed are as follows: To own, construct and manage a spring water system for domestic water, serving water to Spring Water Addition and to Bird Beach Addition on Bird Lakes, Kootenai County, Idaho, said water furnished from three artesian springs or streams in Section 1, T34N R34E, under water right number 4974.

ARTICLE III

The period during which it is to continue as a corporation is in perpetuity.

ARTICLE IV

The post office address of its principal office is Route 24, Rathdrum, Idaho.
